General Safety Information



Securement

It is important that the item(s) you are renting from All Star Rents are secured in a manner that will prevent damage or injury.

- 1. If the item(s) are being transported in or on your vehicle or trailer, you are responsible for the proper loading and securement of those items. We are happy to assist if/when needed.
- 2. If the item(s) are being transported on our trailer or in our vehicle, we will be responsible to properly secure the item(s) at the time you take them. Upon return, you are responsible for the proper securement of the item(s).
 - a. Trailers should not be disconnected. If they are, it is your responsibility to reconnect it properly.

Safe Use

The item(s) you are renting will have unique characteristics that can present various personal safety exposures. We will offer a familiarization on the use of the item(s) in most cases. However, it is important that you understand this should not be considered training or operator certification. If you are not familiar with the use and operation of the item you are renting it is important to make us aware of this and request an Operator Manual for the item(s) you are renting. In the event a manual is not available for any reason, continuing with the rental will be done at your own risk. If you do not feel that you have the knowledge or experience to safely operate the item(s) you are renting we will cease the rental immediately at no cost to you. We must be notified prior to leaving the All Star Rents location or our driver leaving your delivery address.

Operating equipment on slopes or inclines presents unique risks. NEVER operate equipment on slopes that exceed rated operating capacities.

Machines that dig or excavate have the potential to strike utility pipes and/or services. We urge you to call 811 in advance of any excavation or digging projects.

The equipment you are renting may create an exposure to silica dust. Be aware that silica is a cause for respiratory illness. OSHA has set rules and guidelines for exposure to silica. Damage/Break Downs

An inherent risk while operating equipment is that certain operating functions, parts, etc. may fail during operation. It is important that you contact us immediately to address these issues. Continuing to operate damaged equipment can result in personal injury or death. DO NOT attempt to move equipment that has tipped off or over from its normal operating position. Serious equipment damage could result. Again, contact us immediately to address these issues prior to operating the item(s).
