Vehicle Safety Sheet

Your safety is of the utmost importance while you are renting a vehicle from us. Only people that have submitted their driver's license information with All Star Rents and 21 years or older may operate the vehicle you are renting. DO NOT allow others to operate the vehicle. This will be considered a violation of the agreement.

Operate the vehicle in a lawful manner. As the driver, you are solely responsible for operating the vehicle safely. Report any damages to the vehicle to All Star Rents immediately. DO NOT OPERATE if damages to vehicle make it unsafe to operate. In the event of an accident, follow normal post-accident procedures by getting any other driver's names, insurance information, pictures of driver's licenses and pictures of the scene. If you get a flat tire, call the location you rented it from and ask for assistance with road service. Deductible charges will apply as detailed below

LIABILITY INSURANCE. Customer shall maintain liability insurance covering the operation and use of the equipment by Customer, with limits for bodily injury and property damage at least as high as those required by the Financial Responsibility Laws of the state in which the equipment is operated and used by Customer. Upon request of All Star Rents, Customer shall furnish the name of his insurance agent, insurance company, and complete information concerning liability insurance coverage carried. In the event of Customer's breach of this Rental agreement by failure to have or obtain such liability insurance, any insurance coverage which may apply to customer under Rental Center's insurance coverage while Customer is operating and using the equipment is limited to the amounts set forth in the Financial Responsibility Laws contained in California Vehicle Code Section 16056, with a maximum limit of fifteen thousand dollars (\$15,000.00) for bodily injury to or death of one person in any one accident and, subject to such limit for one person, the amount of thirty thousand dollars (\$30,000.00) because of bodily injury to or death of two or more persons in any one accident, and the amount of five thousand dollars (\$5,000.00) for damage to property of others as a result any one accident, or the amounts specified in any amendment to said law.

EQUIPMENT PROTECTION PLAN (EPP): The truck damage and collision waiver is NOT insurance of any kind. It does not provide you with ANY liability coverage. **WE DO NOT SELL INSURANCE!** Your personal automobile policy (or that of your company) covers your liability. Please Note: **SOME POLICIES SPECIFICALLY EXCLUDE SUCH COVERAGE, SO CHECK YOUR POLICY**. If you have questions, contact your agent. **THIS COLLISION WAIVER LIMITS YOUR LIABILITY TO US FOR DAMAGES DONE TO OUR VEHICLES, NOTHING ELSE!** TRUCK RENTAL DAMAGE HAS A \$500.00 DEDUCTIBLE OR 25% OF THE COST OF REPAIRS, WHICHEVER IS GREATER, UNLESS THE VEHICLE WAS OPERATED IN VIOLATION OF ANY OF THE TERMS OF THE RENTAL AGREEMENT, THEN THE ENTIRE COST MUST BE BORNE BY THE CUSTOMER. Tire damage is included in damage charges waived – deductible still applies.

<u>NOTE</u>: ANY OVERHEAD DAMAGE IS EXCLUDED FROM THE EPP! "Overhead" is considered areas above the height of the top of the driver's head (cab roof, cargo box, dump bed, etc.). Customer is responsible for damage to tires as deductible applies. Credit card deposit is to cover additional charges including damage to the vehicle. By signing for these instructions, I understand EPP limits and agree to terms.

MAINTENANCE RADIUS: There is a 75 mile maintenance radius from the closest All Star Rents. Any repairs outside this radius will be the responsibility of the Customer, and are reimbursable in full upon return it the repairs are caused through normal wear and tear and not negligence. A minimum service charge of \$200.00 will be levied if Rental Center goes on a service call outside this 75-mile radius. DO NOT operate any vehicles outside the USA.
